

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to integrityfw.com, and Integrity Family Wellness, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Integrity Family Wellness, Inc. include integrityfw.com and Sun City West Chiropractic & Spinal Injury Center, Inc.. ## Collection of your Personal Information

In order to better provide you with products and services offered, Integrity Family Wellness, Inc. may collect personally identifiable information, such as your:
